### **Foreword**

The text of the International Standard ISO 12001:1996 has been prepared by Technical Committee ISO/TC 43 "Acoustics" in collaboration with Technical Committee CEN/TC 211 "Acoustics", the secretariat of which is held by DS.

This European Standard shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by June 1997, and conflicting national standards shall be withdrawn at the latest by June 1997.

This European Standard has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

For relationship with EU Directive(s), see informative Annex ZA, which is an integral part of this standard.

ISO 12001 deals with clause 1.7.4 (f) of annex A of EN 292-2, requiring that manufacturers must give information on the airborne noise emission by machinery. The correspondence between the physical quantities used in the above-mentioned clause and in ISO 12001 is given hereafter.

The equivalent continuous A-weighted sound pressure level at work stations stated in that clause corresponds to the "measured A-weighted emission sound pressure level at specified positions" in ISO 12001.

The peak C-weighted instantaneous pressure value at work stations stated in that clause corresponds to the "measured C-weighted peak emission sound pressure level at specified positions" in ISO 12001.

The sound power level emitted by the machinery stated in that clause corresponds to the "measured sound power level" in ISO 12001.

According to the CEN/CENELEC Internal Regulations, the national standards organizations of the following countries are bound to implement this European Standard: Austria, Belgium, Czech Republic, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and the United Kingdom.
