This document (prEN 17753:2026) has been prepared by Technical Committee CEN/TC 260 “Fertilizers and liming materials”, the secretariat of which is held by DIN.

This document is currently submitted to CEN Enquiry.

This document will supersede CEN/TS 17753:2022.

prEN 17753:2026 includes the following significant technical changes with respect to CEN/TS 17753:2022:

- the CEN Technical Specification has been adopted as a European Standard including the addition of Annex ZA;
- Introduction updated;
- Scope (Clause 1) updated;
- Normative references (Clause 2) updated;
- Bibliography updated;
- determination of the phosphonates content (5.8) added.

This document has been prepared under a standardization request addressed to CEN by the European Commission. The Standing Committee of the EFTA States subsequently approves these requests for its Member States.
