## European foreword

This document (prEN 17755:2026) has been prepared by Technical Committee CEN/TC 260 “Fertilizers and liming materials”, the secretariat of which is held by DIN.

This document is currently submitted to CEN Enquiry.

This document will supersede CEN/TS 17755:2022.

prEN 17755:2026 includes the following significant technical changes with respect to CEN/TS 17755:2022:

- a) The CEN Technical Specification has been adopted as a European Standard including the addition of Annex ZA;
- b) Scope (Clause 1) updated;
- c) Normative references (Clause 2) updated;
- d) Determination of organic carbon content (5.2) and the dry matter content (5.3) added;
- e) Bibliography updated.

This document has been prepared under a standardization request addressed to CEN by the European Commission. The Standing Committee of the EFTA States subsequently approves these requests for its Member States.

For the relationship with EU Legislation, see informative Annex ZA, which is an integral part of this document.
