This document (prEN 17759:2026) has been prepared by Technical Committee CEN/TC 260 “Fertilizers and liming materials” the secretariat of which is held by DIN.

This document is currently submitted to CEN Enquiry.

This document will supersede CEN/TS 17759:2022.

prEN 17759:2026 includes the following significant technical changes with respect to CEN/TS 17759:2022:

- a) the CEN Technical Specification has been adopted as a European Standard;
- b) update of Scope (Clause 1);
- c) update of Normative references (Clause 2);
- d) Sampling and sample preparation (Clause 7) has been updated;
- e) the use of a nitrogen stream during calibration and measurement (8.1) has been removed;
- f) Clause 10 (Precision) and Annex A including results of inter-laboratory study added;
- g) update of Bibliography.

This document has been prepared under a standardization request addressed to CEN by the European Commission. The Standing Committee of the EFTA States subsequently approves these requests for its Member States.
