This document (prEN 647:2026) has been prepared by Technical Committee CEN/TC 172 “Paper, pulp and board”, the secretariat of which is held by DIN.

This document is currently submitted to the CEN Enquiry.

This document will supersede EN 647:1993.

This document includes the following significant technical changes with respect to EN 647:1993:

- revision of Clause 8 and Clause 9 with the addition of detailed procedures for a 2 h extraction and 30 min extraction;
- inclusion of tea filter papers in the procedure;
- addition of Clause 10 for the analysis of the filtrate;
- addition of Annex A for the calculation of migration of individual compounds.
